# Members Appointed by Municipal Council(s):

Seven (7) by the Municipal Council of the City of Greater Sudbury (As per *Municipal Act, 2001, Ontario Reg. 214/96 s.8(2)*)

One (1) jointly by the Municipal Council of the Town of Espanola, the Municipal Councils of the townships of Baldwin and Sables-Spanish River and the Municipal Council of The Corporation of the Township of Nairn and Hyman

One (1) jointly by the Municipal Council of the Town of Gore Bay, the Municipal Councils of The Corporation of the Town of Northeastern Manitoulin and the Islands and The Corporation of the Municipality of Killarney and the Municipal Councils of the

townships of Assiginack, Barrie Island, Billings, Burpee and Mills, Central Manitoulin, Cockburn Island, Gordon and Tehkummah

One (1) jointly by municipalities of French River, Markstay-Warren and St. Charles

One (1) by Township of Chapleau

The Minister of Municipal Affairs' Order under Section 173(4) of the Municipal Act, 2001, gave effect in January 2009 to the amalgamation of the Township of Barrie Island and the Township of Gordon into a single tier municipality known as the Municipality of Gordon/Barrie Island.

### **Term of Office – Municipal Member**

The term of office of a municipal member of a Board of Health continues during the pleasure of the council that appointed the municipal member but, unless ended sooner, ends with the ending of the term of office of the council. R.S.O. 1990, c. H.7, s. 49 (7).

## Members Appointed by the Lieutenant Governor in Council

The Lieutenant Governor in Council may appoint one or more persons as members of a Board of Health, but the number of members so appointed shall be less than the number of municipal members of the Board of Health. *R.S.O.* 1990, c. H.7, s. 49 (3).

#### **Term of Office - Lieutenant Governor in Council**

A member of a Board of Health appointed by the Lieutenant Governor in Council may be appointed for a term of one, two or three years. *R.S.O.* 1990, c. H.7, s. 51 (1).

#### Vacancy

Where a vacancy occurs in a Board of Health by the death, disqualification, resignation or removal of a member, the person or body that appointed the member shall appoint a person forthwith to fill the vacancy for the remainder of the term of the member. *R.S.O.* 1990, c. H.7, s. 51 (2).

# Disqualification

No person whose services are employed by a Board of Health is qualified to be a member of the Board of Health. *R.S.O.* 1990, c. H.7, s. 51 (3).
