

In general, <u>mobile</u> means that the vaccines will be available in venues where specific populations congregate or live; <u>mass</u> means that vaccines will be available at a community site to which individuals, depending on prevailing eligibility, must present to be immunized; <u>practice</u> means that vaccine will be available at clinics held in the practice settings of specific providers (e.g. Public Health, Primary Care, Pharmacy).
