Ontario Seniors Dental Care Program – Denture Services Provider Factsheet

The following factsheet is intended for internal use by Ontario Seniors Dental Care Program (OSDCP) service providers to support administration of denture services in the OSDCP Schedules of Services for Dentist and Non-Dentist Providers. An accompanying client factsheet entitled *Dentures Under the Ontario Seniors Dental Care Program: What You Need to Know* is also available to support patient awareness and patient-provider communication.¹

Which OSDCP denture services require client co-payment?

The OSDCP requires a client co-payment on denture services. Delivery of services under the codes noted in Appendix A from the OSDCP Schedule of Services for Dentist Providers and OSDCP Schedule of Services for Non-Dentist Providers will require the collection of a co-payment from the OSDCP client, as specified. Co-payment is only required for new denture services. Denture-related preparatory procedures, adjustments, relines, and repairs will not require co-payment from the client.

How much is the co-payment?

The OSDCP is to be delivered by salaried dental providers in Public Health Units (PHUs), Community Health Centres (CHCs), and Aboriginal Health Access Centres

(AHACs), along with delivery through partnership contracts with other entities/organizations or providers/specialists, as needed.

To support consistent application of the co-payment to OSDCP clients across all participating service providers, the total co-payment amounts payable by the client for each applicable service rendered are noted in Appendix A. Co-payments from clients must be collected in accordance with these amounts. Based on the co-payment amounts specified in Appendix A, OSDCP clients can, for example, expect to pay approximately \$80 for a complete set of dentures.

How should co-payments be collected and reported?

It is the PHU's responsibility to collect the client co-payment for the codes outlined in Appendix A. The PHU may determine the best mechanism for collecting co-payments, using existing payment and administration processes at the local level, in collaboration with OSDCP service delivery partners (e.g., CHC, AHAC), as needed.
